





Our Brisbane state-of-the-art laboratory has just been granted NATA accreditation for polychlorinated dibenzo-pdioxins (PCDDs), polychlorinated dibenzofurans (PCDFs) and dioxin-like polychlorinated biphenyls (DL-PCBs) in soil, water, wipes and air samples. Using the latest Triple Quadrupole GC-MS/MS equipped with a high-efficiency EI source that allows for parts per trillion (ppt) and parts per quadrillion (ppg) limits of reporting to be routinely achieved in a variety of matrices.



Eurofins has one of the worldwide competence centres for dioxins that was used to benchmark Brisbane's capabilities and provide the latest analytical advice with respect to the detection of these persistent organic pollutants (POPs).
